BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2022 Annual Operating Budget to add additional line item expenditures codes for Fund 3537, Dept. 0310, Craighead County BJA Connect and Protect Grant and to amend Appropriation Ordinance 2022-13 passed on April 25, 2022 to add additional expenditure code line items. The appropriation passed with the salary of a Craighead County Sheriffs office deputy in 2020, when the grant was applied for. The salary did not take into consideration the salary survey increase or the salary increase allowed for deputy first class status and additional line item expenditure codes needed to allow for accurate coding of expenses.

The purpose of the Craighead County Crisis Intervention Response Initiative is to improve public safety responses and county Crisis Intervention Response Initiative is to improve public safety responses and ESLI PENNY outcomes for individuals with mental illnesses and or co-occurring mental illness and substance abuse issues who come in contact with the justice system implementing Crisis Intervention Teams (CIT) in Craighead County. The Law Enforcement Officer to fill this position needs to be a certified officer with experience, leadership skills and understands crisis intervention training.
