

Craighead County received bids on fire protection equipment. All bidders were bidding comparable equipment with various manufacturers. Craighead County reviewed all bids and found that all bidders did meet specifications within the scope requested.

Upon the request of the Southridge Fire Protection District to review bids, bid documents were sent to them for review. Their complete review includes the following determination. The fire department all pricing quotes as outlined above to ensure that all bids were comparable and met specifications. All bids received were determined to be comparable in equipment and pricing. Each company was requested by the Southridge Fire Department to bring demonstration gear for the firefighters to physically try on and evaluate for functionality and protection. These items included helmets, Nomex hoods, jacket, pants w/suspenders, gloves and boots. The majority of the firefighters expressed their desire to go with CASCO with the following reasons. Helmets fit better and were low profile with less pressure on the head and neck. Hoods and gloves were similar with all companies, but felt that CASCO gloves would be easier to use and hold up better on the fire ground. Jackets and pants were lighter and more mobile and snaps and velcro were high quality and easy to operate. Boots were comfortable and kept the ankle snug with the heels providing support for the legs and back. The Southridge Fire fighters by majority recommended that CASCO fire equipment is the best choice that will keep them safe and less fatigued on the ground fighting fires.



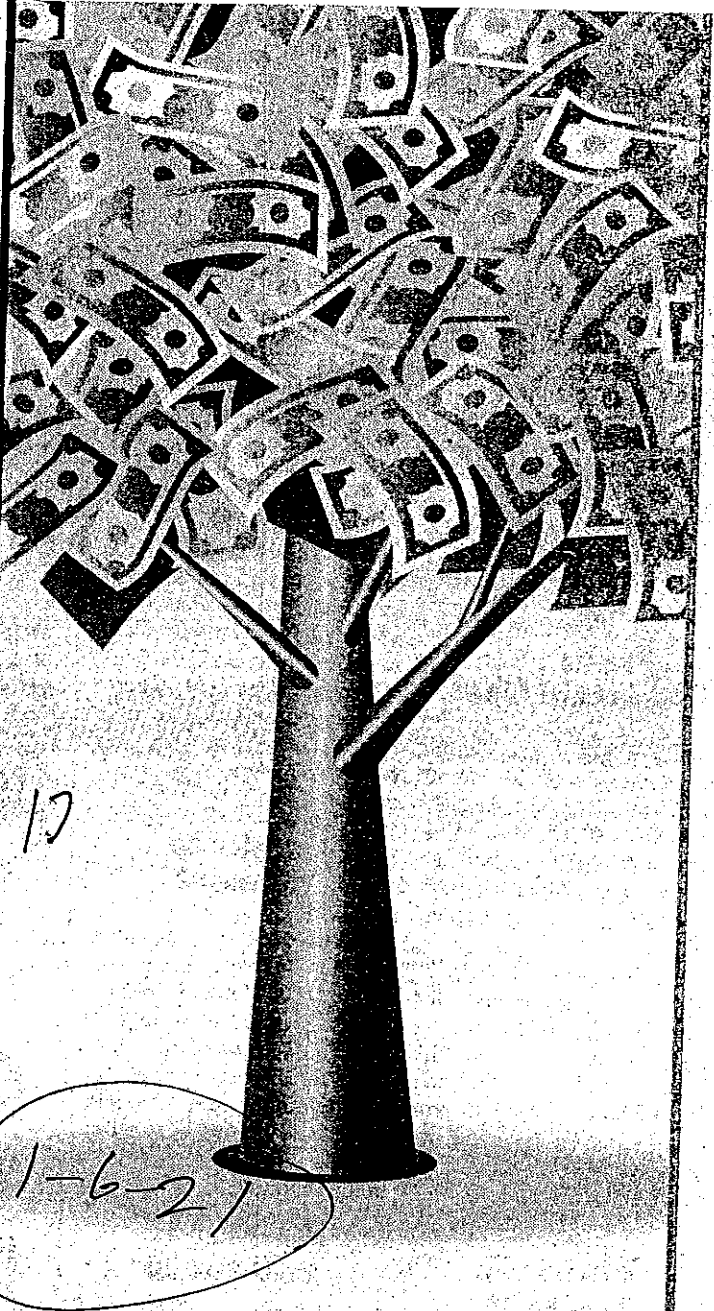
